

## GUIDELINES & TERMS OF AGREEMENT ULTIMATE BONUS barrel racing PACKAGE 2026

### BONUS RACE WORLD FINALS JUNE 8-14, 2026 (Tues- Sun event days) SHAWNEE, OK (HEART OF OK EXPO CENTER)

**THE OFFER:** Included in the Ultimate Bonus Package 2026: 2 Bonus Race World Finals entries for the 2026 BRWF for ONE rider each of those 2 runs includes an Ultimate Bonus Hi Stakes Sidepot. One office fee (\$35). Entry fee breakdown Bonus Race \$130un (\$260 total), Ultimate Bonus \$1200 and office fee \$35, payment plan admin fee \$15. Three payment options are offered (see chart below) discounts/penalties are also outlined in this chart. We will sell a max of 250 UB packages. UB package sales open Sept 5, 2026 and the Sept rate is good through Sept 30, 2025, unless we reach our 250 max before Sept 30. After Dec 30, if we are not at maximum capacity, packages can still be purchased with \$25 late fee per month.

### CONTRACT AMOUNTS

**MONTHLY PAYMENT OPTION** (prices below reflect ONE package) \$25 late fee for every payment that is declined on deadline or for every month delayed in initial signup. If you had more than 1 decline the previous year you are not eligible for the 2025 monthly or 2x payment plan. **FINAL MONTHLY PAYMENT WILL BE BILLED IN APRIL (FINAL MONTHLY PAYMENT FOR 2X WILL BE IN MARCH)**

**MONTHLY PAYMENTS INCLUDE A \$15 ADMIN FEE. 2X PAYMENTS INCLUDE A \$15 ADMIN FEE. PAY IN FULL \$0 ADMIN FEE IF PAID BY DEC 30.**

**Note – 4% credit card fee amount is NOT included in the amounts below.**

Oct-Apr \$215.71 (+4% CC FEE \$8.62) = \$224.33

Nov – Apr \$251.66 (+4% CC FEE \$10.06) = \$261.72

\*Dec – Apr \$302 (+4% CC FEE \$12.08) = \$314.08

\*DECEMBER IS THE LAST MONTH TO SIGN UP FOR MONTHLY PAYMENTS!

**2x PAYMENT OPTION (ONLY OFFERED DURING MONTH OF SEPTEMBER!!! ) Read that again – only offered in September!**

**BY CREDIT CARD ONLY**

SIGN UP BETWEEN Sept 5-30 \$755 (+ 4% CC FEE \$30.20) = \$785.20 - 1<sup>st</sup> payment

2<sup>ND</sup> payment due MARCH \$755 (+ 4% CC FEE \$30.20) = 785.20 - 2<sup>nd</sup> payment

\*PAY IN FULL FEE SCHEDULE (Discount \$10 administration fee) \$25 late fee applies after Dec 31

### **PAYING IN FULL BY CREDIT CARD – ADD 4% CC FEE**

SEPTEMBER - \$1495 + 4% CC FEE (\$59.80) = \$1554.80

OCTOBER/NOVEMBER/DECEMBER

\$1520 (+ 4% CC FEE \$60.40) = \$1570.40

JANUARY - \$1535 (+4% CC FEE \$61.40) = \$1596.40

FEBRUARY - \$1560 (+ 4% CC FEE \$62.40) = \$1622.40

MARCH - \$1585 (+ 4% CC FEE \$63.40) = 1648.40

APRIL - \$1610 (+ 4% CC FEE \$64.40) = \$1674.40

\*Monthly payments must be paid by card and a 4% fee will apply to all card transactions. 1x payments may be made by check with no additional fees charged OR can be paid by credit card with 4% card fee. We reserve the right to return any entry. A limit of 250 packages will be available. Agreements received after the maximum number has been reached will be returned, unprocessed. A late fee of \$25 will be ADDED TO any payment declined for any reason on the due date. (This will be enforced this year.) It is your responsibility to make sure that FUNDS ARE AVAILABLE ON THE DUE DATE EACH MONTH. FOR EXAMPLE – If you sign up for monthly payments on the 10<sup>th</sup> of the month, the monthly payments will process on the 10<sup>th</sup> of each month.

**ACCEPTANCE:** By completing the Ultimate Bonus Package agreement form, you are accepting the offer AND agree to pay in full the CONTRACT AMOUNT as outlined above (based on date of form submission). An additional \$25 late fee will be applied to any payment that we are unable to process due to card being declined. The number packages available for this event is limited, therefore you are not able to drop out of this agreement by not making payment. You can “assign” or sell your spot to another rider, but it must be paid in full before making the transfer, and an additional \$100 office fee is required. MAY 1 is the assignment deadline with a \$100 fee. After MAY 1 we will work with riders on a case by case basis for transferring this package, however it can only be done with a doctor’s release or veterinary release, and a \$100 sub fee. IF you are only subbing a horse after entries close, the normal \$10 sub fee applies. If it is done **AFTER** the MAY 1 deadline the ULTIMATE PORTION sidepot will be the only portion of this package that will be transferable to another rider/horse and a doctor’s release must accompany this. If transferred by doctor’s release, the rider will not be allowed to compete on any other horse. The Bonus Runs (Bonus Race entry fee portion will not be transferable once the entries open. The FINAL deadline to transfer the \$1200 sidepot portion will be TUES June 10<sup>th</sup> at 12 noon. (TRANSFERRING SIDEPOt IS THE ONLY OPTION AFTER APR 30). THIS CAN BE DONE after PHASE 4 OF BARREL ENTRIES CLOSE. ONLY THE \$1200 UB SIDEPOt CAN BE TRANSFERRED AND only TO SOMEONE WITH 2 PAID RUNS IN BONUS RACE.

**CONSIDERATION:** 2 BONUS RACE WORLD FINALS ENTRIES, 2 ULTIMATE BONUS RACE (HI STAKES) SIDEPOt ENTRIES AND OFFICE FEE. ALL TO BE USED BY THE SAME RIDER IN EXCHANGE FOR \$1500+ (WITH APPLICABLE DISCOUNTS/PENALTIES AS OUTLINED ABOVE). PAYOUT: Bonus Race entries will be paid out on a 5D ½ sec split. \$10 of each entry will go towards a “daily payout” paid out 100% in that session. Ultimate Bonus entries will be paid out on a 5D ½ sec split. (89% payout) + \$5000 added Projected payout posted on website based on 250 packages sold. (Each package has a chance at 6 checks including 2 Bonus Race, 2 daily payouts, 2 Ultimate Bonus Sidepot payouts) REFUNDS: In the event of natural disaster, pandemic, or other unforeseen disasters which cause the BRWF in Shawnee, to be cancelled, all fees will be returned apart from the credit card charges 4% and the \$35 office fee and \$15 admin fee, which is paid to administer the payment processing. A RIDER MAY HAVE A MAXIMUM OF 3 UB PACKAGES TOTAL IN THEIR NAME. (TOTAL OF 6 RUNS MAX). NOTE A HORSE MAY NOT RUN MORE THAN 2X IN THE BONUS RACE!

**APPLYING ULTIMATE BONUS RACE PACKAGE credits TO BRWF ENTRIES:**

Your SGP user name is required on the sign up form (this can be setup through our entry system sgpevents.net ) Once full payment is received, we will place a CREDIT in the rider’s name using our online entry system. Once entries open, the rider will then be required to LOG INTO the system and enter specific horses using the credit applied for the Ultimate Bonus. THE 2 BONUS ENTRIES AND ULTIMATE BONUS SIDEPOts CANNOT BE SPLIT AMONG RIDERS! FAILURE TO FOLLOW THIS RULE WILL RESULT IN AUTOMATIC DISQUALIFICATION. They can be split among two different horses ridden by the same rider. No transfer of this package will be allowed after the draw is posted for any reason (see specific rules above).

NO transfers allowed from May 1 until the show begins. UB transfers will have to be done at the event with doctor’s release (only the \$1200 UB can be transferred during that time with \$100 transfer fee)
